If coercion is the tool of tyrants and manipulation is the method of the exploiter, character is the language of the influencer. When leading with a commitment to character, leaders are able to avoid the traps inherent to leadership that requires a culture of intimidation, micromanagement and mind games. In this presentation, Dr. Mellor will review how ethical leadership creates a climate of dignity, responsibility and personal choice. Through the process of clearly communicating expectations and intentionally recognizing ethical behavior, a framework for organizational success emerges. Utilizing a blend of storytelling with research-based findings; this program is designed to provide participants inspiring content with practical application.

- 1. The role of leaders in creating ethical expectations for their organizations.
- 2. Best practices for individuals and organizations seeking to build a value-based culture.
- A practical framework for building and maintaining an ethical culture that leads to greater efficiency, increased engagement and lowered risk.


